Per your request, here is our formal proposal.

In consideration for the Beaver Local School District's Fleet FUEL business, 1st Choice Energy Services agrees to supply the following fuel storage equipment:

- 1- 2,000 dual wall fuel storage tank, high speed pump, hose, nozzle and meter for gasoline usage.
- 1-3,000 dual wall fuel storage tank, (2) high speed pumps with remote dispensers (1 at each end of the tank), hoses, nozzles and meters for diesel fuel usage.

Monitors will also be provided for each tank for full service ordering & delivery.

ALL maintenance for fuel storage tanks, pumps, hoses, nozzles, meters, remote dispensers, and monitors will be covered under NORMAL wear and tear by 1st Choice Energy Services.

There will be NO cost to the Beaver Local School district for usage of above equipment provided all fuel is purchased from 1st Choice Energy Services (Agland Co-Op.) There will be NO delivery or set up fees for the equipment. **Direct wiring and ground prep (if any) will be the responsibility of the Beaver Local School District.**

"On - Road" clear diesel will be provided, unless the district can provide proof of relief, allowing dyed, non-taxed fuel to be used in bus fleet.

1st Choice Energy Services/Agland Co-Op. is making a major investment in NEW equipment. We ask consideration for a "Good Faith" agreement for two (2) years providing fuel at fair market pricing.
